#### Introduction

The 2022-23 Senior Incentive Credit is available to eligible undergraduate sophomore students at the University of Notre Dame. The first 250 eligible sophomore students who commit to living on-campus for the 2022-23 academic year during the Fall 2020 semester will receive up to a \$2,000 housing credit during the 2022-23 academic year.

# **Eligibility**

To be eligible for the Senior Incentive Credit, students must have matriculated to the University of Notre Dame as a new first-time student in Fall 2019 or Spring 2020, or as a sophomore transfer student for Fall 2020. Eligible students must meet all requirements for on-campus undergraduate housing as specified by the Office of Residential Life, the Undergraduate Housing Contract, and the University of Notre Dame. Confirmed students will receive the Incentive Credit for the year in which they apply (2022-23), as long as they have applied for fall 2022 housing before April 30, 2022.

Students who are selected to serve as Resident Assistants by the Office of Residential Life for the 2022-23 academic year are not eligible to also receive the Senior Incentive Credit.

Students who are selected to serve in a Senior Fellow role are only eligible to receive up to a \$1,000 incentive credit.

#### **Request Period**

The Senior Incentive Credit application will be available starting September 28 at 8:00am EDT, and will close on October 11, 2020 at 11:59pm EDT. The form is available online at <a href="https://homeunderthedome.nd.edu">homeunderthedome.nd.edu</a> to eligible students and the Senior Incentive Credit request may only be submitted through this form.

#### **Selection and Confirmation**

Eligible students who submit the Senior Incentive Credit application during the request period and are one of the first 250 students to submit the form will be selected to receive the Senior Incentive Credit for the 2022-23 academic year. The selected students will receive an email from the Office of Residential Life conditionally confirming their status to receive the Senior Incentive Credit. These students are subject to a cancellation fee should they not live on-campus for the 2022-23 academic year. A student's selection by the Office of Residential Life to receive the Senior Incentive Credit is conditional, and is also subject to the approval of the Office of Financial Aid, which must also determine a student's eligibility for aid prior to the 2022-2023 year.

A student cannot receive aid in excess of demonstrated financial need or the total cost of attendance. To the extent the Senior Incentive Credit would increase a student's total aid for the 2022-2023 year beyond demonstrated financial need or total cost of attendance (as determined by the Office of Financial Aid), then the student may be ineligible to receive the Senior Incentive Credit, or a portion of it. If the Office of Financial Aid determines that a student is eligible to receive only a portion of the \$2,000 Senior Incentive Credit, the student is still bound to live on-campus, and remains subject to the stated cancellation policy and fee if the student breaks the commitment to live on-campus. If the Office of Financial Aid determines that a confirmed student is

not eligible to receive any of the Senior Incentive Credit amount, then the student is released from the obligation to live on-campus as dictated by the Senior Incentive Credit terms and conditions, and is no longer subject to the cancellation fee. When a student receives all or a portion of the \$2,000 Senior Incentive Credit, the Financial Aid Office must treat any such credit as a financial aid resource that will factor into the Office's final commitment of assistance.

# **Cancellation / Failure to Live On-Campus**

Students who break the Senior Incentive Credit commitment once it has been confirmed via email by the Office of Residential Life will be responsible for a \$1,000 cancellation fee. This includes students who actively inform the Office of Residential Life of their intention to live off-campus for the 2022-23 academic year, as well as students who fail to apply for on-campus housing for the 2022-23 academic year by April 30, 2022. Student financial aid is not available to pay this penalty. As noted above, students who are determined by the Office of Financial Aid not to be eligible to receive any portion of the Senior Incentive Credit amount are released from their obligation to live on-campus as dictated by the Senior Incentive Credit terms and conditions, at no penalty.

This fee may be waived for students who separate, take a leave of absence, participate in a Notre Dame-affiliated off-campus program, or in other extraordinary circumstances, as determined in the sole discretion of the Office of Residential Life.

If the Senior Incentive Credit has already been applied to a student's account for the 2022-23 academic year at the time of cancellation, Notre Dame may adjust the credit amount total based upon standard charge and aid adjustment rules so as to reflect the student's time actually spent on-campus. Students on the waitlist for the Senior Incentive Credit will not be subject to any cancellation fee in the event they cancel their request by withdrawing from the waitlist.

### **Waitlist**

Eligible students who complete the Senior Incentive Credit application during the request period, but are not among the first 250 students to submit the form, will be placed on a waitlist should any space become available on the Senior Incentive Credit confirmation list. Students' placement on the waitlist will be determined by the date and time their completed applications were received. If a student is moved from the waitlist to the confirmation list, the student is immediately subject to the cancellation policy and fee for the Senior Incentive Credit. The waitlist will conclude on April 30, 2022, when the final confirmation list for the Senior Incentive Credit is communicated to the Office of Financial Aid.

# **Credit Amount and Timing**

The Senior Incentive Credit amount shall total no more than \$2,000 to be applied to the student's account for the 2022-23 academic year – no more than \$1,000 for the fall semester and \$1,000 for the spring semester.

A student cannot receive aid in excess of demonstrated financial need or the total cost of attendance. To the extent the Senior Incentive Credit would increase a student's total aid for the senior year beyond demonstrated financial need or total cost of attendance (which evaluation is made by the Office of Financial Aid in the spring preceding the 2022-2023 academic year), then the student may be ineligible to receive the Senior Incentive Credit, or a portion of it.

Students who are selected to serve in a Senior Fellow position are only eligible to receive up to a \$1,000 incentive credit - \$500 in the fall semester and \$500 in the spring semester.

Students who are selected to serve as Resident Assistants by the Office of Residential Life for the 2022-23 academic year are not eligible to also receive the Senior Incentive Credit.

The Senior Incentive Credit will be applied to the student's account in July 2022 for the fall semester and in December 2022 for the spring semester. If the student receives gift assistance (including the \$2,000 incentive credit) that exceeds the total cost of tuition, fees, books & supplies for the calendar year, the excess may be subject to taxation by the Internal Revenue Service (federal and state).
